
## YOUR ESIA BOARD IS WORKING FOR YOU!

At our December 7 ESIA Board meeting, Matt Hertel and Remi Mendoza from the City Planning Department presented an overview of the General Plan Update, the East Sacramento Community Plan, and the Climate Action Plan. The City completed virtual community workshops in October, and the City Council will be considering a draft Land Use Plan and "Key Strategies" for the General Plan and Community Plans on January 5, 2021. Proposed key strategies include 1) greater array of housing types in existing single-unit neighborhoods, 2) compact mixed-use development in commercial corridors, 3) requiring new buildings to be all electric to eliminate the use of fossil fuels, 4) gradually transition existing buildings to electric, 5) support transition to zero-emission vehicles, 6) increase tree canopy, 7) use an equity framework to prioritize infrastructure, 8) right-size streets to prioritize walking, biking and transit, and 9) eliminate parking minimums. ESIA is closely monitoring the General Plan and East Sac Community Plan. Please see powerpoint by clicking below.

We formed a subcommittee to further explore the impact of the proposals on the East Sacramento community, with a focus on proposed land use changes and electrification. We have previously attended community workshops to give our input. Once there is more "meat" on the City's proposals, we hope to have a neighborhood wide forum.

The ESIA Board is also closely monitoring the homelessness issue, with an emphasis on addressing crime emanating from the camps. We understand this is a very complicated issue and we're trying our best to represent the interests of East Sac. We were especially disheartened to learn of the sexual assault in the McKinley Park Rose Garden on December 1 - please be careful and protect yourself.

The Land Use Committee has considered several development requests recently and we will keep you informed of significant projects.
