ESIA Co-Hosts Forum on City's Homelessness Master Plan

Councilmember Jeff Harris hosted a forum on the City's pending Homelessness Master Plan on Monday evening, February 1. Mr. Harris was joined by Bridgette Dean, Director of Sac PD Community Response Team, Lisa Bates, Executive Director of Sacramento Steps Forward, and Danielle Foster, the City's Housing Policy Manager. He first described various initiatives the City is currently undertaking. The Homelessness Master Plan is driven by the need to look comprehensively at the full spectrum of services and potential sites for homeless facilities given the dire need.

All ESIA Board members participated in the forum. Our Board members emphasized the need to have sites large enough to accommodate the services needed, focusing on Cal Expo and similar sites.

We were pleased to find out efforts are underway to clear the 29th and C Street encampment as alternative beds and sites are now available.

New East Sacramento Park

East Sacramento's newest park is Russ Soloman Park, located in the McKinley Village neighborhood.

The park, located at the western entrance to McKinley Village, is named in honor of Russ Soloman who founded Tower Records. Tower Records was instrumental in shaping the modern music scene in the U.S. and abroad.

The 0.68-acre park is located at 3111 McKinley Village Way (at the intersection of Dullanty Way). Amenities include two open turf areas, tree plantings, a concrete ping pong table, seating areas, and public art designed specifically for the park. The park was completed in October 2020, but unfortunately due to COVID-19, no dedication ceremony was held.

The park is now open and members of the public are welcome to visit.
