Ellen Cochrane, Board member of the Sacramento City School Board, spoke to the ESIA Board about current activities of the School Board, and answered questions from the Board.

1. Emma Loos and David Hilliard of Symphony Development will speak about the 65 East project.

David Hilliard and Emma Loos of Symphony Development presented their project. The company has built student housing projects at other universities. They explained that the project consists of two properties. They will buy streets and improve them to City standards. Folsom Blvd. will be improved based on City standards. The project consists of 184 dwelling units from studios to six beds per unit, housing 750 students. The project also contains 7,500 square feet of retail space on 65<sup>th</sup> Street. There are 330 parking spaces, with no parking on the street. The height is five-six stories.
