## Guest presentation—invited guests and ESIA members welcome

ESIA Scheduled the Guest Presentation for an update by Larry Brohman, Caltrans. Mr. Brohman could not make the meeting, and instead ESIA heard complaints from Staci Edwards, a resident of Midtown, with respect to the homeless encampment on 29th Street nearest the E Street off-ramp. More specifically, Ms. Edwards explained her frustrations with local officials from the City of Sacramento, County of Sacramento, State of California, CHP, Sacramento Police and CalTrans and provided visual examples of the public nuisance and public safety issues created by the homeless population in that area. Nick and Kyle agreed to follow up with the neighbor to determine if there is anyway for ESIA to get involved.
