Minutes of the February 2022 Board meeting

Sarah sent the minutes at the end of this meeting, and after a few corrections via email, the minutes were adopted with a motion by Tricia and a second by Chris.

• Treasurer's report—Brian

The balance reflected a \$1K donation from Jeff Harris. We are presently waiting at El Dorado Savings for the right paperwork reflecting the name change from the Secretary of State. Paul and Chris second – Brian abstained.

Land Use

Brian reported that plans for an ADU were submitted to us that had a variance request but it ESIA thought it was OK. Tricia has signed up for all the alerts from the Planning Department, so she's seeing everything even the ones that don't get sent to us. Discussed the new Development Tracker and briefly the hotel proposed at 30th and L.

Membership

Tom reported that the membership group met last week and discussed the new website and a plug-in that will facilitate the download of a whole membership list. The one-time cost for the tool is \$89. Kathy looked into it and recommended we do it. Tricia wasn't sure what the bylaws require about small expenditures, so just in case, Brian moved, and Nick seconded allowing the expenditure for the additional plug in.

9 people didn't have emails, so letters were sent out.

Chris volunteered to change the Facebook change from ESIA to ESCA, and a list of contacts is being developed to notify (in addition to members) when we're ready to announce the rollout. A press release will be drafted and shared editing, and the logo will be updated, too.

Nothing to report from Kathy, but Brian noted that we have a bill for the old domain name from Page Weavers. They sent an invoice for the next six months – we'll have to pay them until we switch. Kathy recommended we pay it and then get a refund for unused services.
