Neighborhood Safety—Nick

- There was an event at McKinley Park with the Mayor; Nick reported it was a good event, with tough questions asked. Although the Mayor did not initially support a sidewalk ordinance with a misdemeanor, it passed, albeit in a lesser form, and takes effect on the 28th.
- Nick and Kelly were on KFPK for an hour.
- On Saturday, 100 people from Land park gathered to share concerns about Target and small businesses closing. The police came and closed a city block from traffic.

4. Planning for September 28 Forum on Measures O and L
 - a. 9 people have signed up so far; Cecily has prepared some questions, and Tricia sent notice of the event to other neighborhood associations.

 - a. No updates, Tricia reported she hasn’t heard anything.
