Business session—ESCA members welcome

- 1. Minutes of the Nov 2022 Board meeting
 - a. Tricia moved to approve the minutes, Clint seconded. Kathy and Paul abstained. 5-0.
- 2. Treasurer's report—Brian
 - a. The treasurer's report was not available.
- 3. Reports from standing subcommittees

Land Use—Brian

- Brian was absent, but Tricia reported ESCA is waiting to schedule a meeting with the new affordable housing developer at 65th and Folsom until after they answer questions from the City.
- There haven't been any further updates from St. Francis on the aquatic project.
- A few applications have come to the Land Use Committee, but nothing requiring discretionary review. Tricia noted that we haven't gotten any plans for houses on lot splits, which led to a discussion about SB 9 and ADUs.

• It is unclear when the next step will be released on the Missing Middle Study; a revised General Plan update is due to be released by the City in "early 2023" (per the City).

Membership – Tricia

All renewals have been sent out, but we don't have updated figures yet.
 Approximately 40-50 people have not yet renewed; there may be about 150 members total.

Neighborhood Safety—Nick

- Nick reported that some folks are starting to camp in the lot across from Mimosa house on J st. No one is sure who owns it, though; it's believed that the City cleared it once.
- Nick said he isn't getting any return calls from the city about the camps under the freeway, nor is he seeing any enforcement.
- Nick Nicholas is going to take Bridget's place at the Department of Community Response. Unclear on the workings of that group – stats don't seem to be available.
- 4. Council Representation Update
 - Jocelyn from Steinberg's office is going to work with ESCA.
- 5. Clunie Center updates
 - Discussion on the rental rates for community groups, and it was agreed that ESCA will not likely be using the rooms again due to the expense.

parks director and/or commissioner for East Sac to discuss management of the gardens and other amenities.
